2016 NCAA/CFO NATIONAL RULES TEST

For each of the following select the correct answer. There is only ONE correct choice for each question. For any fouls that are not offset, assume that the penalty is accepted (as well as any 10-second runoff) unless it is declined by rule.

- 1. Each member of the offensive line is wearing a towel, all of which are white, 4" by 12", with a small team logo. The snapper's towel also has a large skull-and-cross-bones symbol.
 - a. Only the snapper may wear a towel.
 - b. The skull-and-cross-bones is not legal.
 - c. A maximum of three linemen may wear towels.
 - d. Both the skull-and-cross-bones and the team logo are allowed on the towel.
- 2. At the snap Team A has four linemen numbered between 50-79 and three linemen numbered outside this range. A potential kicker is eight yards deep but there is no potential holder.
 - a. There must always be at least five linemen numbered between 50-79: no exceptions.
 - b. This is a legal formation if and only if it is obvious that a scrimmage kick will be attempted.
 - c. Illegal formation. The potential kicker is not at least 10 yards deep.
 - d. The formation may be made legal by placing a player in position to receive a hand-to-hand snap.
- 3. A game between teams from different conferences has been suspended in the middle of the third quarter very late at night due to weather. It is clear that the game cannot be resumed. The directors of athletics for the participating teams are unable to arrive at an agreement on which option should be in effect.
 - a. The policy of the home team's conference takes effect to decide the outcome.
 - b. The Referee is empowered to decide the outcome.
 - c. The team ahead in the score is declared the winner.
 - d. The game must be declared "no contest."
- 4. Second and seven at the A-25. Team A is ahead in the score late in the second quarter. When ball carrier A22 is tackled in the field of play after a gain of three yards, the game clock reads 1:47. The umpire reports to the referee that he has a flag for holding by snapper A55.
 - a. Clock starts on the snap or the referee's signal, at Team B's option.
 - b. Clock starts on the referee's signal. No option.
 - c. Clock starts on the snap. No option.

- 5. Second quarter. At the snap the game clock reads 0:45. During the play, A55 loses his helmet and A77 is flagged for holding. The ball carrier is tackled inbounds short of the line to gain.
 - a. There is a runoff of 10 seconds, at Team B's option.
 - b. The play clock is set to 40 seconds.
 - c. By rule there is no 10-second runoff.
 - d. None of the above.
- 6. Second quarter. Second and 10 at the B-30 with the game clock running. Guard A66 in a three-point stance misses the snap count and lurches forward, committing a false start. B77 then commits a dead-ball personal foul or a dead-ball foul for unsportsmanlike conduct. The game clock is stopped with 8 seconds remaining.
 - a. The 10-second runoff does not apply because there are fouls by both teams.
 - b. The quarter is extended for one untimed down.
 - c. Team A may not avoid the 10-second runoff by taking a timeout.
 - d. None of the above.
- 7. Team A is in formation to attempt a field goal. At the snap A22 is in position to execute a right-footed place kick and A33 is in position as the holder. The snap goes to A33 who has a knee on the ground. Just after the snap A22 breaks to his left and toward the neutral zone, and A33, while still on his knee, flips a forward pass to A22 who carries the ball beyond the line to gain before he is tackled.
 - a. Legal play; first down for Team A.
 - b. The ball is dead when A33 receives the ball from the snapper because he is grounded.
 - c. Illegal forward pass.
 - d. None of the above.
- 8. Second and 10 at the A-40. In a shotgun formation A11 takes the backward pass from the snapper and hands the ball to back A44. A44 takes a few steps toward the line of scrimmage and then throws a backward pass to A11, who is still inside the tackle box. Avoiding tacklers, A11 scrambles outside the tackle box, and unable to find an open receiver, at the A-35 he throws the ball toward an area where there are no eligible receivers. The ball lands out of bounds beyond the neutral zone.
 - a. A11 may legally end the play in this manner because he took the backward pass from the snapper.
 - b. Foul for two passes thrown during the same down.
 - c. Intentional grounding by A11 because he did not keep the ball before throwing the forward pass.
 - d. None of the above.
- 9. Third and 10 at the A-30. Quarterback A11 drops back to pass. About to be tackled at the A-20, he throws the ball forward to an area where there are no eligible receivers. Tackle A77 catches the pass at the A-28 and is tackled at the A-32.

- a. Illegal forward pass; five-yard penalty at the spot of the foul plus loss of down.
- b. Foul by A77 for illegal touching.
- c. Illegal forward pass. Fourth and 20 at the A-20.
- d. Illegal forward pass; five-yard penalty from the previous spot plus loss of down.
- 10. B33, defending against a legal forward pass beyond the neutral zone, has his back to the ball and is waving his arms in the face of eligible A88, but does not make contact.
 - a. Legal play; not a foul for defensive pass interference.
 - b. Defensive pass interference because B33 does not look back at the ball.
 - c. Defensive pass interference if B33 is within one yard of A88 as he is trying to make the catch.
 - d. None of the above.
- 11. A player on defense sticks out his foot and trips an opponent.
 - a. There is no foul for tripping an opponent.
 - b. Legal unless the opponent is the ball carrier.
 - c. Legal only if the opponent is the ball carrier.
 - d. Personal foul. 15-yard penalty.
- 12. On a punt return, B44 launches at A66 from the blind side and drives his shoulder into him. The force of the contact is at A66's side below the shoulder.
 - a. This is a foul by B44 because of the change of possession.
 - b. Legal block since the forcible contact is not to the head/neck area.
 - c. Personal foul because a blindside block is always illegal.
 - d. Because of the launch, this is a targeting foul against a defenseless opponent.
 - e. None of the above.
- 13. At the snap A82 is positioned on the line of scrimmage to the right side of the formation, 10 yards from the snapper. Back A31, a flanker positioned to the left side of the formation, runs a deep reverse to the right side after receiving the ball from a teammate. As the play develops A82 blocks linebacker B62 toward the line through the original position of the ball. The block by A82 is below the waist and directly at the front, clearly inside the "10 o'clock to 2 o'clock" width. The block occurs before ball carrier A31 has reached the line of scrimmage.
 - a. Legal block because A82 is unrestricted for blocking below the waist.
 - b. Foul---illegal crackback block.
 - c. Legal block because of the location of the ball carrier at the time of the block.
- 14. At the snap A82 is positioned on the line of scrimmage to the right side of the formation, 10 yards from the snapper. Back A31, a flanker positioned to the left side of the formation, runs a deep reverse to the right side after receiving the ball from a teammate. As the play develops A82 blocks linebacker B62 toward the line through the original position of the ball. The block by A82 is below the waist and directly at the

front, clearly inside the "10 o'clock to 2 o'clock" width. The block occurs after the ball carrier A31 is clearly beyond the line of scrimmage.

- a. Legal block because A82 is unrestricted for blocking below the waist.
- b. Foul---illegal crackback block.
- c. Legal block because of the location of the ball carrier at the time of the block.
- 15. Back A22 is stationary inside the tackle box at the snap. After the snap he shoots between the tackle and the guard on his side and blocks low on linebacker B55 before the ball has left the tackle box. The contact is at B55's thigh from the side and is directed straight ahead of A22.
 - a. Legal block.
 - b. Foul—illegal block below the waist.
 - c. This would be a legal block only if A22 were in motion at the snap.
- 16. At the snap tight end A85 is aligned six yards from the snapper. Before the ball has left the tackle box A85 blocks tackle B77 below the waist at the side.
 - a. Foul—illegal block below the waist.
 - b. Legal block because A85 is unrestricted for blocking below the waist.
 - c. Legal block because the opponent is on the line of scrimmage at the snap.
- 17. A10 is in a shotgun-type formation 7-1/2 yards behind the snapper, who has his head down and is looking backward through his legs. Immediately after the snap, nose guard B55 charges directly at the snapper and contacts him by pushing him backward.
 - a. Foul because Team A is in a scrimmage kick formation.
 - b. Legal play because Team A is not in a scrimmage kick formation.
 - c. This action could be legal or illegal, depending on whether there is a kick.
- 18. During a dead-ball time, a head coach or an assistant coach is flagged for coming out to the numbers and cursing the officials in a loud and abusive manner. This is the coach's second unsportsmanlike conduct foul during the game.
 - a. The coach is disqualified and may remain on the sideline outside the team area.
 - b. The coach is disqualified and may watch the game from the press box.
 - c. The disqualification applies only if this is a head coach.
 - d. The coach is disqualified, must leave the field, and must remain out of view of the playing area for the remainder of the game.
- 19. After the down is over, Team A sends in three substitutes, and three players begin to leave the field. - d. Legal play because A88 was not replaced by a substitute.
- 20. Fourth and eight at the A-48. From a scrimmage kick formation, A32 punts the ball to the B-7 where it hits B25 on the leg. As the ball rolls along the ground, B25 then kicks it at the B-4 to prevent Team A from recovering. The ball bounces into Team B's end zone and over the end line.
 - a. The result of the play is a safety.
 - b. Foul by B25 for illegally kicking the ball.
 - c. The play is covered by postscrimmage kick rules.
 - d. Team A may decline the penalty and take the two points.
 - e. All of the above.
 - f. None of the above.
- 21. Third and five at the B-20. A11 fumbles the ball behind the line of scrimmage. The loose ball is illegally batted forward by a teammate at the B-27 and then goes out of bounds at the B-23.
 - a. 10-yard penalty ONLY, spot foul.
 - b. 10-yard penalty plus loss of down; spot foul
 - c. 15-yard penalty ONLY, previous spot
 - d. 15-yard penalty plus loss of down; spot foul
- 22. On the opening kickoff, Team A attempts an on-side kick at the A-35. The ball hits a Team B player in the back at the A-43 and a member of Team A falls on the ball at the A-39. When the Team A player falls on the ball, his foot is touching the sideline.
 - a. Team B's ball, first and 10 at the A-39.
 - b. Team A's ball, first and 10 at the A-39.
 - c. Team A's ball, first and 10 at the A-43.
- 23. Team A free kicks from the A-35. A55 touches the ball at the A-43, and Team B possesses the ball and is downed at the A-46. Team B may put the ball in play at EITHER the A-46 or the A-43.

- 24. Third and 20 at the A-40. B77 sacks quarterback A11 at the A-35. After the ball is dead B77 stands over A11 and curses him, which draws a flag from the referee.
 - a. First and 10 at the 50.

 - c. Fourth and 5 at the B-45.
 - d. Fourth and 10 at the 50.

- 25. Third and seven at the B-40. The Team A passer is still in the tackle box and under duress when he throws a pass at the feet of the tight end A88 who is engaged and blocking a defender. A88 was not in position to catch the pass.
 - a. Intentional grounding.
 - b. Legal pass to a receiver in the area; not intentional grounding.
- 26. Second and seven at the B-10. The game clock is running late in the fourth quarter. Guard A66 in a three-point stance lifts his hand from the ground and is flagged for a false start. When the play is shut down there are 25 seconds on the game clock. Team A has one timeout. Team B informs the referee that they want the 10-second runoff.
 - a. Team B may decline the penalty and accept the 10-second runoff.
 - b. Team A must use its final timeout and thus avoid the 10-second runoff.

 - d. The game clock must start on the snap.
- 27. Second and 10 at the B-30 late in the first half. Guard A66 in a three-point stance misses the snap count and lurches forward, committing a false start. The game clock is stopped with 8 seconds remaining. B77 then commits a dead-ball foul for unsportsmanlike conduct. Team B indicates that they want the 10-second runoff.
 - a. Both penalties are enforced and the period is extended for one untimed down following the 10-second runoff.
 - b. The 10-second runoff does not apply because the fouls offset.
 - c. The half is over on the 10-second runoff and the penalty for B77's foul is declined by rule.
 - d. The half is over on the 10-second runoff and the penalty for B77's foul is enforced at the start of the second half.
- 28. Second and 10 at the A-30. Back A22 is positioned wide to the left of the formation, eight yards from the ball. He then goes in motion to his right and crosses beyond the ball. At the snap he is behind the right guard, facing the line of scrimmage and running in place.
 - a. A22 may block below the waist anywhere because he is inside the tackle box at the snap.
 - b. A22 is restricted in blocking below the waist because he was in motion at the snap.
 - c. A22 is restricted in blocking below the waist because his initial position was outside the tackle box.
 - d. A22 is allowed to block below the waist as long as he does not leave the tackle box.

- 29. Third and Goal at the B-8. Fourth quarter of a tie game. With the game clock running and Team A out of timeouts, A66 commits a false start with 7-seconds remaining on the game clock.
 - a. Third and Goal at the B-13; clock starts on the ready for play.
 - b. Third and Goal at the B-13; clock starts on the snap.
 - c. 10-Second Clock Subtraction; 4th guarter is over.
- 30. At the end of a down, the Umpire sees that A66 is wearing black eye shade that contains a phone number written in white. Team A has no timeouts remaining in the half.
 - a. Illegal equipment. A66 must leave the game for at least one play and may not return until the eye shade is corrected.
 - b. Illegal equipment. The special rule for eye shade does not allow A66 to remain in the game even if Team A had a timeout available.
 - c. Eye shade containing words or numbers is not classified as illegal equipment.
 - d. Illegal equipment. A66 is not required to leave the game if he can fix the eye shade before the next play begins.
- 31. Team A punts on fourth and 12 at the A-25. Team A is flagged for an illegal shift. During the kick B72 blocks below the waist at the B-45. Receiver B28 signals and makes a fair catch at the B-40.
 - a. No option: Fouls offset and the down is repeated.
 - b. Team B may refuse offsetting fouls and have the ball at the B-30.

- 32. On a try attempt at the B-3, Team B is flagged for lining up in the neutral zone at the snap. B80 blocks the kick, recovers the ball, and returns it until A18 tackles him with a horse-collar tackle at the A-45.
 - a. Offsetting fouls. The down is not repeated and the try is over.
 - b. The offside penalty is cancelled and the horse-collar penalty is enforced on the kickoff.
 - c. Offsetting fouls. The try is repeated at the B-3.

- 33. Second and eight at the A-35. With the ball at the left hash mark, back A44 is split outside the tackle box to his left. The QB runs up the middle and is tackled at the A-40. As the play develops, A44 blocks below the waist at the A-35. The direction of his block is straight ahead and within the 10-2 range forward of the defender being blocked.
 - a. Legal block. Third and three at the A-40.
 - b. Illegal block below the waist. Previous spot foul. Second and 23 at the A-20.

- 34. First and 10 at the B-40 late in the first quarter. Team A lines up with four players in the backfield and seven on the line of scrimmage, all numbered legally. Before the snap, end A84 goes in motion from a standing position (no false start) and is five yards behind the neutral zone at the snap. QB A12 carries for a seven-yard gain before being driven out of bounds.
 - a. Foul for not enough players on the line of scrimmage.
 - b. Legal play. Second and three at the B-33. Clock starts on the snap.
 - c. Legal play. Second and three at the B-33. Clock starts on the ready.
 - d. Illegal motion. Five yards, previous spot. Repeat first down.
- 35. A team has a total of twelve points. They may reach this total number of points by which combination(s) of scoring plays?
 - a. Two touchdowns.
 - b. One touchdown and two field goals.
 - c. One touchdown, two safeties, and one field goal.
 - d. a and b only
 - e. *a, b* and *c*
- 36. First and 10 at the B-25. Team A commits a live-ball illegal shift on a play in which A34 carries the ball across Team B's goal line.
 - a. First and 15 at the B-30. Clock starts on the snap.
 - b. First and 15 at the B-30. Clock starts on the ready.
- 37. Third and 10 at the B-30. Team A trails by 7-points. Ball carrier A22 advances across B's goal line. While following the play, the HL runs into the Team A coach who is straddling the sideline at the B-25 watching the action. Time expires in the fourth quarter during the down.
 - a. Touchdown for Team A; Enforce sideline interference on the try for point.
 - b. Third and 20 at the B-40. Extend the period for one timed down.
 - c. This is a foul only if Team A has earlier received a sideline warning.

- 39. EXTRA PERIOD. During the first possession series, runner A34 fumbles. B63 recovers and advances the ball to Team B's 30-yard line where he fumbles. A82 recovers while grounded at the B-30.

 - b. The ball is dead when B63 recovers the fumble.

- 42. EXTRA PERIOD. Fourth and seven at the B-30. Team A's field goal attempt is unsuccessful and B47 is the first to touch the ball, at the B-20. A26 recovers the ball at the B-17.
 - a. Team A's possession series continues. First and 10 for Team A at the B-17.
 - b. Team A's possession series is over. First and 10 for Team B at the original 25-yard line.
- 43. Fourth and 10 at the A-5. B77 blocks the punt and the ball bounces into Team A's end zone. A21 bats the ball from the end zone into the field of play and it goes out of bounds at the A-6.
 - a. Safety. No option.
 - b. First and goal for Team B at the A-6.
 - c. First and goal for Team B at the A-3.
 - d. If the penalty is accepted fourth down must be repeated.
 - e. None of the above.
- 44. On the kickoff, Team A attempts an onside kick at the A-35. A19 is well beyond his restraining line when the ball is kicked. B25 blocks A88 into the ball at the A-43 and the ball rolls to the A-46 where B16 muffs it. The ball bounces out of bounds at the A-41.

- a. Team A foul, free kick out of bounds.
- b. Team B's ball, first and 10 at the A-36.
- c. Illegal touching by A88 at the A-43.
- d. Because B16 muffs the ball out of bounds, it belongs to Team A at the A-41.
- 45. Second quarter. Safety B22 intercepts a pass and fumbles on the return. A46 recovers the ball at the B-45 and runs to the B-40 where he fumbles. The ball rolls out of bounds at the B-35.
 - a. First and 10 for Team A at the B-40. The starting of the clock depends on the amount of time left in the second quarter.
 - b. First and 10 for Team A at the B-35. Clock starts on the snap.
 - c. First and 10 for Team A at the B-40. Clock starts on the snap.
 - d. First and 10 for Team A at the B-40. Clock starts on the Referee's signal.
 - e. First and 10 for Team A at the B-35. Clock starts on the Referee's signal.
- 46. Second and eight at the A-35. With the ball at the left hash mark, back A33 is split outside the tackle box to his left. The QB runs up the middle and is tackled at the A-40. As the play develops, A33 blocks below the waist against B55 at the A-49. The block is at the side.
 - a. Legal block. Third and three at the A-40
 - b. Illegal block below the waist. Second and 23 at the A-20.
 - c. Illegal block below the waist. Second and 18 at the A-25.
- 47. Fourth and five at the B-30. Late in the fourth quarter Team A trails by one point. Their field goal attempt is partially blocked and is bouncing at Team B's 10-yard line. A42 bats the ball into the end zone where A22 downs it after it hits the ground.
 - a. Illegal touching by A42.
 - b. The ball is dead when it hits the ground in the end zone.
 - c. Team B's ball at the B-30.
 - d. All of the above.
 - e. Touchback; Team B's ball at the B-20.
- 48. Third and goal at the B-3. A10 takes the direct snap, fumbles at the B-2 and the ball rolls into the end zone. B51 recovers in the end zone. He attempts to run the ball out but is tackled in the end zone, the ball never coming into the field of play. During B51's run B83 clips at the B-6.
 - a. The ball is dead when B51 recovers in the end zone.
 - b. The clipping penalty results in a safety.
 - c. First and 10 for Team B at the B-3.
 - d. First and 10 for Team B at the B-10.
- 49. Fourth and 2 at the B-32 late in the second quarter. A12 in the shotgun formation takes the snap and runs off-tackle to his right. At the B-29 he is hit and fumbles. A42

recovers the ball at the B-34, carries for a few yards and is driven out of bounds at the B-25. The game clock reads 2:35.

- a. First and 10 for Team B at the B-34.
- b. First and 10 for Team A at the B-29.
- c. First and 10 for Team A at the B-25.
- d. The game clock starts on the ready-for-play.
- e. None of the above.
- 50. During the first quarter B44 intercepts a pass and returns the ball across Team A's goal line. Covering the play along Team B's sideline, the Line Judge drops his flag at the A-20 because he has to run around Team B personnel who have come onto the field. Team B has had no game administration warnings to this point in the game.
 - a. No score. Team B's ball after enforcement of the penalty for the live-ball foul.
 - b. No foul. The score counts. Team B is issued its first sideline warning.
 - c. The score counts. The 15-yard penalty is enforced on the try or the succeeding kickoff.
 - d. The score counts. The five-yard penalty is enforced on the try or the succeeding kickoff.
- 51. Second and seven at the A-23. A12 takes the snap and drops straight back. He scrambles outside the tackle box and, under pressure at the A-16, throws the ball away. The pass hits the ground near the hash mark at the A-27. Tackle A77 was at the A-30 when A12 released the pass.
 - a. Foul by A12, intentional grounding.
 - b. Foul by A77, ineligible receiver downfield.
 - c. Both a and b are correct answers.
 - d. Legal play.
- 52. Second and 10 at the B-30. QB A12 runs to the B-28 before throwing a forward pass. B40 intercepts at the B-20 and returns to the B-35 where he is driven out of bounds. B66 clips at the B-30 during the return. The game clock reads 7:30 in the third quarter when the ball is declared dead.
 - a. Offsetting fouls; the down must be replayed—no option.
 - b. Team B may decline offsetting fouls to keep the ball following completion of the clipping penalty.
 - c. When the ball is ready to be snapped for the next play, the play clock will have started counting down from 40 seconds.
- 53. Fourth and 10 at the A-40. B23 catches the punt at the B-17 and carries the ball to the B-21 where he fumbles. During the fumble B92 holds A46 at the B-18. A37 recovers the ball at the B-20 and returns it across Team B's goal line.
 - a. The penalty is enforced at the previous spot and the down replayed.
 - b. The touchdown counts and the holding penalty is carried over to the try or the kickoff.
